



## Terms and Conditions

**The 23rd edition of ETRIA World TRIZ Future Conference "Towards AI aided Invention and Innovation" will be held completely online at the Offenburg University, Germany, on 12-14 September 2023**

Registration for the conference must be made online, via the conference website. The registration fee must be paid in total prior to the conference start and delegate's arrival on the conference site. An invoice will be sent with a submission of registration. The registration is considered and will be confirmed upon receipt of the full payment. The price includes the totality of the service, the participant can't benefit from a discount, a refund or a credit note if he does not intend to benefit from the totality of the service.

The TFC Organizers reserve the right to modify the program in case of absence of one or more speakers. The participant is informed that the TFC Organizers may take photos/videos during the event. Unless expressly requested, the participant authorizes the TFC Organizers to film and/or photograph him/her, and to disseminate these contents as part of the communication of the event.
